This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 238 An Act to Amend the Laws Governing Paper Streets**

**SUMMARY**

This bill provides that title to property taken for town ways is not required to be in fee simple absolute if the property includes a paper street and public rights in the property have not been terminated pursuant to the Maine Revised Statutes, Title 23, section 3031, subsection 1, section 3032 or 3033. The bill also allows municipalities under certain circumstances to assign rights-of-way to landowners abutting paper streets.
