### JOINT STANDING COMMITTEE BILL SUMMARIES

### JULY 1993

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

## An Act Regarding Seating on a Motorcycle or Motor-driven Cycle

#### **SUMMARY**

This bill would have repealed the section of law regarding permissible seating on a motorcycle or motor-driven cycle or in a sidecar and replaced it with substantially the same language in outline form. In addition, the new section would have made it mandatory for a passenger riding on a motorcycle or motor-driven cycle to be seated behind the operator. The operator would have been responsible for a violation.

The committee amendment (H-64) changed the language in the violation section of the bill to clarify that a violation would be a traffic infraction.

#### SUMMARY

This bill would have required all motor vehicle operators and passengers to wear safety seat belts unless an operator or passenger had a medical condition, documented by a physician, that precluded wearing a seat belt.

The committee amendment (S-88) clarified that the exemption for passengers exceeding the seating capacity of a vehicle would apply only when all seat belts in the vehicle were in use. It added a provision allowing enforcement only when a vehicle was stopped for a suspected violation of another traffic offense. It replaced the term, "civil violation," with the term, "traffic infraction." It changed the penalty to a fine not less than \$25 nor more than \$50. It also added the effective date of January 1, 1994 and a fiscal note to the bill.
