**JULY 1993**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 465 An Act to Coordinate Public Sector Occupational Health and Safety Regulations**

**SUMMARY**

This bill transfers rule-making authority on minimum safety standards for firefighters from the Director of the Bureau of Labor Standards to the Board of Occupational Safety and Health to ensure coverage of all public sector firefighters and improve consistency in regulatory authority, enforcement activities and appeals. The Committee Amendment (H-54) added a fiscal note.

**LD 466 An Act Allowing the Bureau of Labor Standards to Enter into Reciprocal Agreements in the Area of Employment Standards with Other States**

**SUMMARY**

This bill authorizes the Director of Labor Standards to enter into reciprocal agreements with other jurisdictions to aid in the enforcement of employment standards violations, such as unpaid wages, when an employer's home office is located outside of Maine. The Committee Amendment (H-58) added a fiscal note.

**LD 472 An Act to Facilitate the Payment and Collection of Safety Education and Training Fund Assessments**

**SUMMARY**

This bill clarifies that the assessment for the Safety Education and Training Fund be made on the basis of the most recent calendar year for which data is available. The bill permits the establishment of penalties for late payment of up to 6% per year and provides that willful failure to pay the assessment is a civil violation. The Committee Amendment (H-53) added a fiscal note.

**LD 480 An Act to Provide Flexibility in Establishing Payroll Schedules for Municipal Employees**

**SUMMARY**

This bill would have removed the requirement that cities and towns pay their employees on a weekly basis. The minority report of the committee would have required the employer to pay its employees at least once every two weeks unless the employee agreed to a less frequent schedule.
