LD 49 **An Act to Set Reasonable Dioxin Levels** **ONTP**

SUMMARY

This bill would have established an ambient water quality standard for dioxin consistent with the guidance standard developed by the federal Environmental Protection Agency. The scientific basis of that standard is currently under review by the federal government. The committee declined to enact this bill prior to the completion of the federal scientific reassessment.

LD 256 **An Act to Allow the Use of Advanced Lightweight Beverage Containers** **PUBLIC 591**

SUMMARY

Effective September 1, 1994, this bill allows the sale of metallized or plastic film containers that meet standards requiring significant reductions in the total weight of packaging material necessary to store beverages. This bill also exempts this type of packaging from the bottle deposit law.

COMMITTEE AMENDMENT "B" (H-798) adds language allowing the sale of aseptic beverage packaging (juice boxes) in the State. Aseptic beverage packaging will also be exempt from the bottle deposit law. The Maine Waste Management Agency is directed to evaluate recycling efforts undertaken by the affected manufacturers and to report on the results of these efforts to the Legislature in 1995. The Joint Standing Committee on Energy and Natural Resources is authorized to report out legislation upon review of this report, if needed, to amend the laws regarding aseptic beverage packaging. This amendment also adds a fiscal note to the bill. (See LD 975)

LD 554 **An Act to Establish a Pilot Project to Mediate Certain Environmental Disputes** **P & S 65**

SUMMARY

This bill would have required the Commissioner of Environmental Protection to make an offer of mediation prior to proceeding with any administrative enforcement action or civil litigation.

COMMITTEE AMENDMENT "A" (H-745) replaces the bill. It requires the Department of Environmental Protection to establish a pilot project to use mediation to resolve certain disputes relating to uncontrolled hazardous waste sites. Mediation could be used to resolve clean-up and cost allocation issues, but would not be used for law enforcement matters without approval of the Attorney General. The pilot project would operate until June 1, 1996, with interim reporting requirements and a final report due by November 1, 1996. The amendment also adds a fiscal note to the bill.
