**JULY 1993**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**An Act Concerning the Purchase of Liquor by Establishments  
Licensed to Sell Liquor on Premises**

**SUMMARY**

This bill permits agency liquor stores to deliver liquor to establishments that are licensed to sell spirits for consumption on premises. The bill also permits establishments licensed to sell spirits for consumption on premises to purchase liquor from any state liquor store or any agency store regardless of the establishment's distance from a state liquor store.

Committee Amendment "A" (S-170) replaces the original bill. The amendment permits agency liquor stores to deliver liquor to establishments that are licensed for the sale of liquor on premises and permits on-premise licensees to purchase liquor from any state store or agency store regardless of the licensed establishment's distance from a state liquor store.

The amendment also clarifies the price of spirits sold under the Maine Revised Statutes, Title 28-A, section 606, subsection 1-A must equal the price of spirits sold at state liquor stores. An agency liquor store and an on-premise licensee shall each retain a copy of the licensee order form upon completion of the transaction.

This bill would have allowed landlords of tenants-at-will to enter their dwelling units only 2 times a year for inspection and only after the landlord has given a 10-day notice.

**SUMMARY**

This bill would provide a procedure for 3rd parties to qualify for primaries in legislative districts and for subsequent primaries and general elections. A party would qualify for primaries in a legislative district if its candidate in the preceding general election received at least 15% of the vote in that district and had declared intent to qualify the party before that election. The bill also would provide requirements for municipal caucuses and statewide conventions.
