This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 908 An Act to Eliminate the Seasonal Legal Researcher Position at the Public Utilities Commission and to Make Certain Other Changes

SUMMARY

This bill eliminates 2 Seasonal Legal Researcher positions at the Public Utilities Commission pursuant to Public Law 1991, chapter 780, Part KKK and changes the titles of the utility financial analyst, chief utility accountant and utility accountant III positions in the finance division to utility analyst.

LD 926 An Act to Allow Disclosure of Residential Electrical Costs

SUMMARY

This bill requires utilities to disclose to tenants and other customers or prospective customers residential electrical energy cost and consumption information for the preceding 12 months.

The committee amendment (H-224) makes several technical changes and reassigns the language to a new chapter in Title 14.

SUMMARY

The Maine Revised Statutes, Title 35-A, section 3133, subsection 2 currently has a "notice of intent to file" requirement and explicitly permits the Public Utilities Commission, in its discretion, to waive the advance notice requirement. Title 35-A, section 3133-A, subsection 1 has a similar "notice of intent to file" requirement but provides no explicit authorization for the commission to waive the advance notice requirement. This bill adds identical language to section 3133-A, subsection 1 that permits the commission to entertain requests to waive the advance notice requirement in that section.

SUMMARY

This bill proposed to require that the Public Utilities Commission, in considering and adopting an electric rate design, to minimize rates. The bill also proposed to require utilities to submit proposals for rate design which include incremental-use rates or maintenance-of-existing-use rates.
