This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

The purpose of this bill is to deorganize the Town of Greenfield.

The amendment (S-76) clarifies the bill in several ways. The amendment adds a mandate preamble to the bill authorizing passage of the bill without state funding for mandated deorganization election costs if enacted by a 2/3-vote of the membership of both bodies. The amendment corrects the reference to the school unit from which Greenfield is withdrawing and inserts language withdrawing the town from Secondary Applied Technology Region 4. The amendment directs the State Tax Assessor to assess real and personal property by April 1, 1993, adds an appropriation and a fiscal note to the bill.

This bill affords the State Police a mechanism to recoup the costs for activities that the State Police provides to several federal agencies. The assistance includes canine support, underwater recovery and security for activities other than presidential details.
