This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

<i>DIED ON ADJOURNMENT</i>	<i>Action incomplete when session ended; bill died</i>

LD 989 **An Act to Limit to 5 Years Certain State Contracts** ONTP

SUMMARY

With some exceptions, this bill imposes a time limitation of 5 years on contracts entered into by state agencies. Contracts that exceed this limitation are subject to legislative review.

LD 1004 **An Act to Increase the Fee for Marriage Licenses** ONTP

SUMMARY

This bill increases the fee for a marriage license from \$10 to \$20, except in cases where the law requires 2 licenses, in which case the fee is increased from \$5 each to \$10 each. LD 1229 is a related bill.

LD 1032 **RESOLUTION, Proposing an Amendment to the Constitution of Maine Providing for the Free Election of the Secretary of State and the Attorney General** ONTP

SUMMARY

This resolution provides for direct popular election of the Secretary of State and the Attorney General to 4-year terms in the manner currently provided for the election of the Governor. The terms are staggered so that the Secretary of State will first be elected in 1994 and the Attorney General will first be elected in 1996. LD's 698, 743, 1255, 1291 and 1296 are related bills.
