BILL SUMMARIES**

JULY 1993

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

The Committee Amendment (H-484) replaces the original bill, adds an emergency clause and incorporates many of the changes proposed in LD 164, LD 203, LD 708 and LD 1144. It expands the maximum hours for 16 and 17 year olds to 10 hours per day and 50 hours per week when school is not in session, and from 20 to 28 hours in a school week if there is an authorized school closure. It allows the older minor to begin work as early as 5 a.m. on a non-school day and clarifies that they may not work past 10 p.m. on a day before a school day or past midnights on other days. The amendment also changes the language controlling the hours of the day a 14 or 15 year old may work so that all days of the year are covered and it repeals the subminimum wage effective September 1, 1993. It exempts work as a theatrical or film actor and clarifies the exemption for work in the initial processing of farm crops, it gives the Bureau rulemaking authority, and it provides that the Bureau's poster on employment laws need not be updated.

The Senate Amendment (S-366) to the Committee Amendment adds the standard mandate preamble and replaces the fiscal note.

LD 1128 **An Act Concerning Unemployment Insurance** ONTP

SUMMARY

This bill would have amended the so-called ABC test in the unemployment security laws. Under this bill, a contractor could use an independent contractor to perform services that may or may not be in the usual course of the contractor's business and, if the other prongs of the ABC test are met, the independent contractor would not be an employee of the contractor.

LD 1130 **An Act to Amend the Minimum Safety Standards for Firefighters** PUBLIC 285

SUMMARY

This bill provides firefighters with greater flexibility in protective clothing while still ensuring adequate safety by allowing them to wear 3/4 length boots in conjunction with approved station uniforms.

The Committee Amendment (S-153) removes any change to the statutory safety standard on firefighter clothing and addresses the problem by allowing the Board of Occupational Safety and Health to issue advisory rulings on the application of the safety standards.

LD 1144 **An Act Concerning the Working Hours of Minors** ONTP

SUMMARY

This bill broadens the exemptions from the laws limiting the working hours of minors to include work performed as a theatrical or film actor.

This provision was incorporated into LD 1180.
