LD 1227 An Act to Define the Liability of Gas Utilities and Natural Gas Pipeline Utilities

SUMMARY

The bill would have provided for the allocation of liability involving gas or natural gas accidents. It would have repealed the current standard of strict liability and created a standard of care higher than ordinary due care.

The bill was carried over from the First Regular Session.

COMMITTEE AMENDMENT "A" (S-534) was the Minority Report. It would have replaced the bill by simply repealing the section of law establishing the strict liability of gas distributors. Not adopted.

LD 1243 An Act Concerning Sexual Abuse Laws

SUMMARY

The bill would have strengthened existing laws against sexual abuse of minors in several ways. Some provisions were adopted in the Committee Amendment to LD 1109 during the First Regular Session.

The bill was carried over from the First Regular Session.

COMMITTEE AMENDMENT "A" (H-898) replaces the bill. It elevates by one class each class of any unlawful sexual contact crime when the State pleads and proves that the crime included penetration of the genitals or anus, such as by insertion of a finger or a fist, directly or through clothing.

LD 1266 An Act to Allow a Casino to be Constructed by the Passamaquoddy Tribe in Calais for the Purpose of Gambling

SUMMARY

This bill would have required the Governor to negotiate with the Passamaquoddy Tribe for the purpose of entering into a compact to permit the tribe to conduct gaming in Calais under the federal Indian Gaming Regulatory Act. The bill also would have authorized the inclusion in Passamaquoddy Indian Territory of lands in Calais approved by the City Council for acquisition by the tribe.

This bill was carried over from the First Regular Session.

After extensive committee work on this bill, a joint order was introduced to authorize the committee to report out bills as House papers to avoid any risk of violating Article IV, Part 3, Section 9 of the Maine Constitution which requires that bills for raising a revenue must originate in the House.
