This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill was carried forward from the 1st Regular Session.

The bill proposed to eliminate Public Utilities Commission jurisdiction over cable TV pole attachment rate disputes, thus transferring, by default, jurisdiction to the Federal Communications Commission. The commission is required under existing law to adopt specific rules governing the settling of these disputes. The commission has adopted such rules (Chapter 880, effective 10/27/93).

SUMMARY

This bill was carried forward from the 1st Regular Session.

The bill proposed to establish the Emergency Services Communication Agency within the Department of Public Safety to implement and manage the statewide E-9-1-1 system.

COMMITTEE AMENDMENT "A" (S-452) replaces the bill. The amendment establishes the Emergency Services Communication Bureau within the Department of Public Safety. Working with the E-9-1-1 Council, the bureau is directed to estimate costs and develop the system design and performance standards necessary for implementation and management of the statewide E-9-1-1 system. The amendment also directs the bureau and council to make recommendations for the specific location of public safety answering points and makes certain information confidential. The bureau is further directed to report back to the Legislature with recommendations on these subjects.

The amendment requires telephone utilities to levy a surcharge of 2¢ per month on telephone exchange lines to fund the initial phase of system design.

The amendment also repeals outdated provisions of the law relating to E-9-1-1 capability requirements of municipalities and the establishment of the statewide E-9-1-1 system.

In addition, the amendment makes the allocation necessary for the establishment of the Emergency Services Communication Bureau. This allocation will complement expenditures of bond revenues on technical aspects of system design, data base development and municipal technical assistance in data collection.

This bill was carried forward from the 1st Regular Session.

Deregulating consumer-owned water utilities was one of the recommendations of the Commission on Governmental Restructuring. The recommendation appeared in the 2nd Regular Session of the 115th Legislature in L.D. 2330, Part G. It was not enacted.
