**LD 1389 An Act to Restructure the Department of Defense and
Veterans' Services**

COMMITTEE REPORT

AMENDMENTS ADOPTED

SUMMARY

This bill reorganizes the Department of Defense and Veterans' Services by moving the Maine Emergency Management Agency to the Department of Public Safety. It requires the appointment of the Adjutant General to be reviewed and confirmed by the Legislature. The Deputy Adjutant General position is abolished and in its place the Adjutant General may appoint an assistant adjutant general who will be the Director of the Military Bureau. This position must rotate between members of the Air National Guard and the Army National Guard every 3 years. It also requires the military to comply with all state statutes and rules unless expressly exempted. Compliance of the state military with antidiscrimination requirements is clarified and military personnel are allowed to appeal personnel decisions to the Maine Human Rights Commission. The bill also makes persons activated in the National Guard subject to the Military Code of Justice.

This bill was carried over to the Second Regular Session.

**LD 1411 An Act Concerning the Eligibility of Children
of Disabled Veterans to Obtain Education Benefits**

SUMMARY

This bill enables a spouse or a child of an eligible veteran who wants to pursue a course of study that is not available at a state-supported school or institution in this State to attend a state-supported postsecondary school or institution in a state that offers that course of study, with tuition paid by the Division of Veterans' Services.

This bill was carried over to the Second Regular Session.

**LD 1458 An Act to Clarify the Role and Purpose of the Maine
State Retirement System**

AMENDMENTS ADOPTED

SUMMARY

This bill transfers the retirement system's audit functions to the Department of Audit. It directs the Executive Director of the Maine State Retirement System to simplify payroll and reporting requirements and requires the establishment of a schedule of fees, interest and penalties related to failure to provide accurate and complete information and failure to provide information necessary in a timely manner. The bill allows the system to begin to pay retirement benefits on the basis of estimated benefits, with subsequent correction on receipt of final payroll and other necessary information. The bill provides that the executive director, with approval of the Board of Trustees of the Maine State Retirement System, may delegate the executive director's duties to other retirement system staff. The bill revises the current statutory requirement that the system's actuary prepare an evaluation of each

legislative document by requiring an actuarial evaluation only when considered necessary by the retirement system or by the proper legislative committee.

This bill was carried over to the Second Regular Session.
