This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill establishes the Family and Community Care Assistance Program, which provides financial incentives to families who are able and willing to provide home-based care for persons who would otherwise be eligible for Medicaid benefits in long-term nursing facilities. The program makes available state funds, which would have been spent towards the cost of the institutional care, to be used for certain expenditures in a family, congregate housing or other setting for community-based care.

This bill also strengthens the State's current nursing home preadmission screening process by making it mandatory for prospective Medicaid recipients and by adding a nursing home diversion component. In addition to evaluating the appropriateness of nursing home care, the diversion component requires the Department of Human Services to inform nursing home applicants if appropriate home or community-based care could be arranged.

The bill also replaces references to "nursing home" with the term "nursing facility" to make the law consistent with federal Medicaid regulations.

SUMMARY

This bill consolidates substance abuse programs operated by various state agencies into the Office of Substance Abuse. It immediately moves all General Fund money appropriated to other departments for substance abuse services and appropriates that money to the Office of Substance Abuse. It directs the Office of Substance Abuse to develop a plan to further consolidate all state-run substance abuse programs, regardless of funding source. The bill also repeals the existing Maine Council on Alcohol and Drug Abuse Prevention and Treatment and establishes the Substance Abuse Services Commission, which has the duty of overseeing and directing the Office of Substance Abuse.

Amendment H-563 changes the original bill as follows.

1. It adds the Director of the Office of Substance Abuse to the membership of the Interdepartmental Council and eliminates the members of the current Interdepartmental Council from the membership of the Substance Abuse Services Commission. A physician, superintendent, elementary educator, attorney, higher education representative, private sector employer and substance abuse practitioners in the areas of education, prevention and treatment are added to the membership of the commission, increasing the total number of members from 15 to 17. The per diem authorized in the bill is changed to allow expenses only for members of the commission. The amendment also clarifies that the commission provides oversight to the Office of Substance Abuse but does not direct its activities.

- 2. The amendment eliminates the Comprehensive Health Planner II position in the Department of Mental Health and Mental Retardation and deappropriates All Other funds in the Office of Substance Abuse in an amount that reflects the total deappropriation for the Office of Substance Abuse recommended in the Governor's budget for fiscal year 1994-95. The Office of Substance Abuse is directed to recommend reallocation of the All Other cut if it finds administrative savings as substance abuse services are consolidated in the office.
- 3. Language is added to the bill to clarify that the Office of Substance Abuse continues current education efforts when the Department of Education program is transferred to the office. Also, transitional language is added to clarify that the current incumbents retain their positions, along with their accrued rights, benefits and privileges.

Amendment H-631 clarifies how appointments are made to the Substance Abuse Services Commission and corrects an internal cross-reference in the bill.

Amendment S-316 further specifies the rights, benefits and privileges that are retained by employees transferred under the bill.

Amendment S-324 requires that the Office of Substance Abuse allocate a percentage of funds for prevention programs in FY 1994 and 1995 that is at least the same as the percentage allocated in FY 93. It also requires the Office of Substance Abuse and the Department of Education to enter into an agreement regarding continuation of school-based prevention programs.

This bill did not pass, but all of its provisions, as amended by H-563, H-631, S-316 and S-324 were enacted as part of the biennial budget bill. See P.L. 1993, c. 410, Part LL.
