### **MAY 1994**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### **SUMMARY**

This bill does the following.

- 1. Corrects a provision relating to ballot access in a presidential preference primary;
- 2. Clarifies the provisions relating to enlarged ballots for visually impaired voters;
- 3. Allows clerks to use the same procedure for inspecting candidate ballots as for inspecting referendum ballots;
- 4. Clarifies the procedure for recording test ballots;
- Simplifies the Secretary of State's responsibility regarding tabulated results for write-in candidates;
- Clarifies who may complete an application for voter registration on behalf of a member of the Armed Forces;
- 7. Clarifies the application process for a people's veto referendum and the direct initiative of legislation and establishes an official date of issuance, which begins a period of circulation during which a voter may collect signatures for the petition; and
- 8. Simplifies the procedure for processing absentee ballot applications and the procedure for determination of residency for voter registration purposes.

COMMITTEE AMENDMENT "A" (H-947) replaces the original bill and makes the following changes to the election laws:

- 1. Clarifies the process for determining residence for the purpose of voter registration;
- 2. Adds a new subchapter, National Voter Registration Act, which outlines the requirements for providing voter registration opportunities in state agencies pursuant to federal law;

- Corrects a provision relating to candidates being placed on ballots for presidential preference primaries;
- 4. Clarifies the provisions relating to enlarged ballots for voters who are visually impaired;
- Allows clerks to use the same procedure for inspecting candidate ballots as for inspecting referendum ballots;
- 6. Clarifies the procedure for recording test ballots;
- 7. Simplifies the Secretary of State's responsibility regarding tabulated results for write-in candidates;
- 8. Clarifies who may complete an application for voter registration on behalf of a member of the Armed Forces:
- 9. Clarifies the application process for a people's veto referendum and the direct initiative of legislation, and establishes an official date of issuance, which begins a period of circulation during which a voter may collect signatures for the petition; and
- Simplifies the procedure for processing absentee ballot applications.

This amendment also adds an appropriation section and a fiscal note to the bill and conforms existing law to current drafting standards.

SENATE AMENDMENT "A" (S-557) TO COMMITTEE AMENDMENT "A" clarifies that a person seeking or holding the office of judge of probate may engage in any political activity that would be lawful for a candidate to any other elected county office or for any other elected office or offices not made incompatible by the Constitution of Maine.

SENATE AMENDMENT "B" (S-612) TO COMMITTEE AMENDMENT "A" deletes the General Fund appropriation and replaces the fiscal note.

### LD 1638 An Act to Strengthen Enforcement of Manufactured Housing ONTP Warranties

#### **SUMMARY**

This bill would have enabled the State's Manufactured Housing Board to enforce Maine's explicit manufactured housing warranty law and the implied warranty of merchantability. The bill would have created a new warranty on the installation of manufactured homes. The bill also would have required that the Manufactured Housing Board develop recommended licensing qualifications and submit them to the Legislature by January 15, 1995.

Many of the issues in this bill were incorporated into LD 1453, An Act to Make Changes in the Manufactured Housing Laws.
