This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. An Act Concerning Business Directional Signs on Certain Controlled Access Highways

SUMMARY

This bill allows the placement of business directional signs in certain controlled access highways that are designed to bypass existing business districts. Currently, official business directional signs are prohibited from the interstate highway system and controlled access highways by rule.

COMMITTEE AMENDMENT "A" (H-748) adds a fiscal note to the bill.

An Act to Modify the Manufacture of Motor Vehicle Registration Plates

SUMMARY

This bill allows funds from the Environmental Trust Fund to be used for marketing of the environmental registration plate and production and marketing of goods using the license plate design. Proceeds from the sale of the products must be credited to that fund. The bill specifies that the Secretary of State will be the authorizing authority when a request is made to reproduce an environmental plate. It allows for assessment of a penalty if a registration plate is reproduced without proper authorization. The bill allows the Secretary of State the option of using a framed border on registration plates.

COMMITTEE AMENDMENT "A" (H-819) allows vehicles assigned to the Department of Conservation and the Department of Inland Fisheries and Wildlife to display environmental plates in lieu of specially designated state plates. It clarifies that money from the fund can be used to market the environmental registration plates and to produce and market products using the design. It amends the allocation in Public Law 1993, chapter 410 to reflect this change. It changes the date of availability of the University of Maine System license plates to no later than February 1, 1995. It also adds an emergency preamble and clause and a fiscal note to the bill.

An Act to Establish a Financial Assistance Program for Utilities Burdened as a Result of State Highway Construction

SUMMARY

Pursuant to Public Law 1991, chapter 860, the Department of Transportation was required to file a report with the Joint Standing Committee on Transportation for the development of a program to provide financial assistance to utilities experiencing serious financial hardship as a result of the relocation of facilities that are part of bridge and highway projects.

This bill implements the report presented to the Joint Standing Committee on Transportation in March 1993 establishing the financial assistance program for water utilities and combination water and sewer

utilities that have an annual revenue of \$15,000,000 or less. Under this program, the Department of Transportation will provide interest-free loans for up to 90% of the utility relocation cost when the cost of the utility relocation is 5% or more of the utility's prior fiscal year revenues.

COMMITTEE AMENDMENT "A" (H-759) caps total outstanding loans at \$3,000,000. The amount loaned in a fiscal year may not exceed the amount allocated for that fiscal year plus the unencumbered balance in the Small Utility Loan Program reserve account. The amendment establishes the Small Utility Loan Program as a nonlapsing account and allocates \$250,000 to the program for fiscal year 1994-95. These funds are transferred from the Highway and Bridge Improvement program. The amendment also adds a fiscal note to the bill.

An Act to Enable the Use of Former Exit 5 on the Maine Turnpike for Access to an Adjacent Liquor Store and Hotel and Conference Center Facility

SUMMARY

This bill allows the Maine Turnpike Authority to permit the use of former exit 5 on the Maine Turnpike in Saco for access from the turnpike to a liquor store, conference center, restaurant and hotel complex to be developed on land now owned by the City of Saco and requires signs identifying the service to be placed at appropriate distances on the turnpike.

COMMITTEE AMENDMENT "A" (S-448) clarifies the Maine Turnpike Authority's power to establish a logo signing program and to charge a fee for logo signs on the Maine Turnpike. The amendment allows for either a liquor store or a retail store at the Saco Plaza. It changes the language relating to placement requirements for signs to the Saco Plaza. It requires the Maine Turnpike Authority to submit a status report on adoption of a logo signing program to the Joint Standing Committee on Transportation. The amendment also makes technical changes and adds a fiscal note to the bill.

SUMMARY

The bill as amended by committee amendment H-736 removes from the motor vehicle laws the exemption from the use of a child safety seat when the driver is not the parent of the child. The amendment corrects an error in the original bill. It also makes technical changes and adds a fiscal note to the bill.
