## JOINT STANDING COMMITTEE BILL SUMMARIES

#### MAY 1994

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

utilities that have an annual revenue of \$15,000,000 or less. Under this program, the Department of Transportation will provide interest-free loans for up to 90% of the utility relocation cost when the cost of the utility relocation is 5% or more of the utility's prior fiscal year revenues.

COMMITTEE AMENDMENT "A" (H-759) caps total outstanding loans at \$3,000,000. The amount loaned in a fiscal year may not exceed the amount allocated for that fiscal year plus the unencumbered balance in the Small Utility Loan Program reserve account. The amendment establishes the Small Utility Loan Program as a nonlapsing account and allocates \$250,000 to the program for fiscal year 1994-95. These funds are transferred from the Highway and Bridge Improvement program. The amendment also adds a fiscal note to the bill.

#### **SUMMARY**

This bill allows the Maine Turnpike Authority to permit the use of former exit 5 on the Maine Turnpike in Saco for access from the turnpike to a liquor store, conference center, restaurant and hotel complex to be developed on land now owned by the City of Saco and requires signs identifying the service to be placed at appropriate distances on the turnpike.

COMMITTEE AMENDMENT "A" (S-448) clarifies the Maine Turnpike Authority's power to establish a logo signing program and to charge a fee for logo signs on the Maine Turnpike. The amendment allows for either a liquor store or a retail store at the Saco Plaza. It changes the language relating to placement requirements for signs to the Saco Plaza. It requires the Maine Turnpike Authority to submit a status report on adoption of a logo signing program to the Joint Standing Committee on Transportation. The amendment also makes technical changes and adds a fiscal note to the bill.

The bill as amended by committee amendment H-736 removes from the motor vehicle laws the exemption from the use of a child safety seat when the driver is not the parent of the child. The amendment corrects an error in the original bill. It also makes technical changes and adds a fiscal note to the bill.
