LD 1680 An Act to Encourage Efficiency in School Spending

AMENDMENTS ADOPTED**SUMMARY**

This bill would have allowed schools to retain 75% of the savings attributable to efficiency savings to fund basic programs and services for students. Administrative positions would not have been eligible for funding with efficiency savings.

Under current law, unallocated balances in excess of 3% of a school unit's previous year school budget must be used to reduce the state and local shares of education subsidy. This bill would have exempted unallocated balances that are a result of efficiency savings from that requirement.

LD 1690 An Act Concerning Unusual Enrollment Increases in Schools

AMENDMENTS ADOPTED**SUMMARY**

This bill would have made possible an increase in a school unit's state subsidy when the unit experiences an unusual increase in the number of students whose tuition must be paid to schools outside the unit. Under the provision, a school that experiences a 10% or greater increase in the number of secondary students whose tuition is paid to public or approved private schools is eligible for increased state subsidy. The increased state subsidy is limited by the amount appropriated by the Legislature for this purpose. The bill would have been retroactive to July 1, 1993 to permit assistance for the current school year.

LD 1698 An Act to Eliminate the Maine School Building Authority

S-406

SUMMARY

This bill repeals the law authorizing the Maine School Building Authority, which was established to assist local school administrative units in the construction of educational facilities. Since all of the bonds issued by the authority will be recalled as of March 1994, the responsibilities of the authority have been accomplished.

COMMITTEE AMENDMENT "A" (S-406) repeals references in the Maine Revised Statutes, Titles 5 and 30-A to the Maine School Building Authority and moves language repealed by the bill to another section of Title 20-A to maintain the Commissioner of Education's authority to take land for school purposes in the unorganized territory.
