All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. This bill would have removed Whistleblower's Protection Act and workers' compensation retaliation cases from the jurisdiction of the Maine Human Rights Commission.

LD 1754 An Act Regarding the Discharge of Mortgages

SUMMARY

The original bill would have permitted attorneys admitted to practice and in good standing in the State to discharge mortgages by affidavit if the mortgagee does not do so. The procedure would require appropriate notice to the prior mortgagees. The affidavit must be based on the attorney's knowledge concerning the payment of the prior mortgage and the affidavit must be recorded in the registry of deeds in which the property lies.

The COMMITTEE AMENDMENT (H-765) restricts the application of the bill to the discharge of mortgages on residential one to four family owner-occupied dwellings and provides that the new procedure does not apply if the holder of the mortgage is a financial institution authorized to do business in the State. The amendment also clarifies the effect of an affidavit recorded under the new procedure.

SUMMARY

The bill would have required medical personnel and medically-related personnel to report suspected domestic abuse to appropriate law enforcement agencies. Immunity from liability would have been extended to those who report suspected abuse in good faith. The bill is modeled on the required reporting provisions of the child abuse and neglect laws.
