SUMMARY

On September 21, 1993, the federal National and Community Service Trust Act was enacted to engage citizens in meeting critical needs through direct community-based service. The Act requires that every state wishing to participate in national service initiatives create a bipartisan commission on national and community service or a comparable entity. This bill would have created the Maine Commission on National Service. The State Planning Office is directing the first phase of Maine's participation in the National Service Trust Act. Future legislation will likely be necessary.

SUMMARY

The original bill sought to establish that schools in Maine may observe and celebrate religious holidays but not in a way that promotes or endorses religion or religious doctrine.

COMMITTEE AMENDMENT "A" (S-459) replaces the bill. The amendment establishes that a public school may acknowledge a religious holiday by conveying a message of pluralism and freedom of belief in some manner or form that does not endorse religion. It derives from United States Supreme Court opinions in Allegheny County v. Greater Pittsburgh ACLU, 492 U.S. 573 (1989) and Lee v. Weisman, 505 U.S. ___, 112 S. Ct. 2649 (1992). Whether the particular acknowledgement of a religious holiday in a public school is constitutional will, under the guidance of the United States Supreme Court opinions, depend upon the context in which the acknowledgement occurs in the school. The context may include, among other things, the symbols used, the physical setting, the fact that the acknowledgment occurs with students and the type of school exercise in which the acknowledgement occurs.

SUMMARY

During the First Regular Session of the 116th Legislature, a provision was inserted in Public Law 1993, chapter 355 to transfer ownership of a building on the campus of Southern Maine Technical College to the Department of Environmental Protection. This bill is being presented jointly by the Governor, the Department of Environmental Protection and the Maine Technical College System to repeal the portion of Public Law 1993, chapter 355 that transferred ownership of the Southern Maine Technical College building to the Department of Environmental Protection. This bill takes effect retroactively to the date that Public Law 1993, chapter 355 took effect.
