Re: Bill Summaries, 119th Legislature, 1st Regular Session

Enclosed please find a summary of all bills, resolves, joint study orders, joint resolutions and Constitutional resolutions that were considered by the Joint Standing Committee on Appropriations and Financial Affairs during the 1st Regular Session of the 119th Legislature. The summary describes each bill or order and relevant amendments as well as the final action. Also included is a statistical summary of bill activity by the committee. Please note the effective date for all non-emergency legislation enacted in the 1st Regular Session (unless a later date is specified in a particular law) is September 18, 1999. Joint orders are effective when passed.

The document is organized for convenient reference to information on bills handled by the committee this session. It is organized by bill (LD) number and two indices are located at the back of the document that group bills by subject and by LD number. Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

*CARRIED OVER* ..... *Bill carried over to Second Regular Session*  
*CON RES XXX*..... *Chapter # of Constitutional Resolution passed by both Houses*  
*CONF CMTE UNABLE TO AGREE*..... *Committee of Conference unable to agree; bill died*  
*DIED BETWEEN BODIES*..... *House & Senate disagree; bill died*  
*DIED IN CONCURRENCE*..... *One body accepts ONTP report; the other indefinitely postpones the bill*  
*DIED ON ADJOURNMENT* ..... *Action incomplete when session ended; bill died*  
*EMERGENCY*..... *Enacted law takes effect sooner than 90 days*  
*FAILED EMERGENCY ENACTMENT/FINAL PASSAGE*..... *Emergency bill failed to get 2/3 vote*  
*FAILED ENACTMENT/FINAL PASSAGE* ..... *Bill failed to get majority vote*  
*FAILED MANDATE ENACTMENT*..... *Bill imposing local mandate failed to get 2/3 vote*  
*NOT PROPERLY BEFORE THE BODY* ..... *Ruled out of order by the presiding officers; bill died*  
*INDEF PP* ..... *Bill Indefinitely Postponed*  
*ONTP* ..... *Ought Not To Pass report accepted*  
*OTP ND*..... *Committee report Ought To Pass In New Draft*  
*OTP ND/NT* ..... *Committee report Ought To Pass In New Draft/New Title*  
*P&S XXX* ..... *Chapter # of enacted Private & Special Law*  
*PUBLIC XXX*..... *Chapter # of enacted Public Law*  
*RESOLVE XXX*..... *Chapter # of finally passed Resolve*  
*UNSIGNED* ..... *Bill held by Governor*  
*VETO SUSTAINED*..... *Legislature failed to override Governor's Veto*  
*READ AND PASSED*..... *Joint Order passed by the House and Senate*  
*PASSED AS AMENDED* ..... *Joint Order passed as amended by the House and Senate*

**An Act to Authorize a General Fund Bond Issue for the Repair and Renovation of Schools**

LD 269, in Part A of the bill proposed a \$35,000,000 bond issue for public school construction, renovation and repairs that would be presented to the voters in November 1999. This bond proposal was in line with a recommendation of the Governor's Commission on School Facilities which presented a plan to the Governor and the Legislature designed to address Maine's public school construction, renovation and repair needs. That recommendation was that the State issue \$35,000,000 in general obligation bonds in each of fiscal years 1998-99 and 1999-00.

The commission also recommended an immediate General Fund appropriation of \$30,000,000. Public Law 1997, chapter 787 included a General Fund appropriation of \$20,000,000 to the School Revolving Renovation Fund. Part B of this bill proposed to appropriate \$10,000,000 to the program to bring the total appropriation level to \$30,000,000. The bill was carried over to the Second Regular Session of the 119th Legislature.
