Re: Bill Summaries, 119th Legislature, 1st Regular Session

Enclosed please find a summary of all bills, resolves, joint study orders, joint resolutions and Constitutional resolutions that were considered by the Joint Standing Committee on Appropriations and Financial Affairs during the 1st Regular Session of the 119th Legislature. The summary describes each bill or order and relevant amendments as well as the final action. Also included is a statistical summary of bill activity by the committee. Please note the effective date for all non-emergency legislation enacted in the 1st Regular Session (unless a later date is specified in a particular law) is September 18, 1999. Joint orders are effective when passed.

The document is organized for convenient reference to information on bills handled by the committee this session. It is organized by bill (LD) number and two indices are located at the back of the document that group bills by subject and by LD number. Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

CARRIED OVER *Bill carried over to Second Regular Session*
CON RES XXX..... *Chapter # of Constitutional Resolution passed by both Houses*
CONF CMTE UNABLE TO AGREE..... *Committee of Conference unable to agree; bill died*
DIED BETWEEN BODIES..... *House & Senate disagree; bill died*
DIED IN CONCURRENCE..... *One body accepts ONTP report; the other indefinitely postpones the bill*
DIED ON ADJOURNMENT *Action incomplete when session ended; bill died*
EMERGENCY..... *Enacted law takes effect sooner than 90 days*
FAILED EMERGENCY ENACTMENT/FINAL PASSAGE..... *Emergency bill failed to get 2/3 vote*
FAILED ENACTMENT/FINAL PASSAGE *Bill failed to get majority vote*
FAILED MANDATE ENACTMENT..... *Bill imposing local mandate failed to get 2/3 vote*
NOT PROPERLY BEFORE THE BODY *Ruled out of order by the presiding officers; bill died*
INDEF PP *Bill Indefinitely Postponed*
ONTP *Ought Not To Pass report accepted*
OTP ND..... *Committee report Ought To Pass In New Draft*
OTP ND/NT *Committee report Ought To Pass In New Draft/New Title*
P&S XXX *Chapter # of enacted Private & Special Law*
PUBLIC XXX..... *Chapter # of enacted Public Law*
RESOLVE XXX..... *Chapter # of finally passed Resolve*
UNSIGNED *Bill held by Governor*
VETO SUSTAINED..... *Legislature failed to override Governor's Veto*
READ AND PASSED..... *Joint Order passed by the House and Senate*
PASSED AS AMENDED *Joint Order passed as amended by the House and Senate*

Resolve, to Provide Incentives for School Breakfast Programs in Maine Public Schools

LD 1558 proposed to establish a one-time grant program which would have been administered by the Department of Education to encourage schools with a high percentage of their student body eligible for free or reduced-price school meals to establish school breakfast programs.

Committee Amendment "A" (S-64) proposed to clarify that the appropriation was made on a one-time basis. While this bill was indefinitely postponed, a General Fund appropriation of \$240,000 for this purpose was included in Public Law 1999, chapter 401, Part KK.

An Act to Implement Training for School Counselors at the Maine Youth Center and Upgrade Pay Classifications

LD 1573 proposed to provide General Fund appropriations totaling \$4,500,000 over the 2000-2001 biennium to the Department of Corrections to increase the pay classification for Training School Counselor positions and to provide additional training to the staff at the Maine Youth Center.

LD 1590

An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 to Support the Construction of the Gulf of Maine Aquarium

LD 1590 proposed a bond issue in the amount of \$10,000,000, that would have been used by the Department of Economic and Community Development to support the construction of the Gulf of Maine Aquarium to create marine-related jobs, to educate Maine residents and visitors about Maine's inland and coastal waters and to support fishery research from Mt. Katahdin to the Gulf of Maine. The bill was carried over to the Second Regular Session of the 119th Legislature.
