Matters to be Presented to the Voters in Forthcoming Elections

I To be presented at the November 6, 1973 special election:

A. Constitutional Resolutions

1. Resolution, Proposing an Amendment to the Constitution Providing for Regulation of Municipal Borrowing by the Legislature. *Res. no. 1*

Question: "Shall the Constitution be amended as proposed by a Resolution of the Legislature providing for regulation of municipal borrowing by the Legislature?"

2. Resolution, Proposing an Amendment to the Constitution Clarifying the Status of Bills Presented to the Governor and Time the Legislature Adjourns. *Res. no. 2*

Question: "Shall the Constitution be amended as proposed by a resolution of the Legislature clarifying the status of bills presented to the Governor and time the Legislature adjourns?"

B. Other Matters

1. An Act Providing for a State Lottery.

Public Laws of 1973, Chapter 570.

Question:

"Shall 'An Act Providing for a State Lottery' become law?"

2. An Act to Authorize Bond Issues in the Amount of \$3,000,000 for Acquisition of Real Property for State Parks Private and Special Laws of 1973, Chapter 138.

Question:

"Shall the State provide for the acquisition of real property for state parks by issuing bonds in the amount of \$3,000,000?"

3. An Act Creating the Power Authority of Maine Initiated bill No. 1, submitted to the people as provided in Article IV, Part Third, Section 1 of the Constitution.

Question:

To be formulated by the Secretary of State.

II To be presented at the November, 1974 General Election:

- A. An Act to Authorize Bond Issue in the Amount of \$7,800,000. to Build State Highways. Private and Special Laws of 1973, Chapter 110

Question:

"Shall a bond issue be ratified for the purpose set forth in 'An Act to Authorize Bond Issue in the Amount of \$7,800,000 to Build State Highways', passed by the 106th Legislature?"

- B. An Act Authorizing the Creation of the Maine Inland Fisheries and Game Acquisition Fund and the Issuance of Not Exceeding \$4,000,000 for the Financing Thereof
Private and Special Laws of 1973, Chapter 118

Question:

"Shall a bond issue be ratified for the purpose set forth in 'An Act Authorizing the Creation of the Maine Inland Fisheries and Game Acquisition Fund and the Issuance of Not Exceeding 4,000,000 Bonds for the Financing Thereof', passed by the 106th Legislature?"

- C. An Act to Authorize Bond Issues in the Amount of \$25,000,000 to Provide for School Building Construction
Private and Special Laws of 1973, Chapter 136

Question:

"Shall a bond issue be ratified for the purposes set forth in 'An Act to Authorize Bond Issues in the Amount of \$25,000,000 to Provide Funds for School Building Construction', passed by the 106th Legislature?"

III Special Matters - To be presented on local ballots only:

- A. An Act to Permit the Sale of Beer and Table Wine on Sunday for Off-Premise Consumption
Public Laws of 1973, Chapter 196

IV

Question:

Local option, in each case, to be placed on the ballot at the General Election of November 1974.

- B. An Act to Annex Town of Brunswick to Sagadahoc County
Private and Special Laws of 1973, Chapter 87

Question:

Referendum: to be submitted to the voters of the Town of Brunswick in 1973 and if approved, to be submitted to the voters of Sagadahoc County in 1974.

- C. An Act to Authorize Oxford County to Raise Money for the Development of an Airport in the Rumford-Mexico Area
Private and Special Laws of 1973, Chapter 94

Referendum: County of Oxford

Question:

"Shall the county raise, by bonds, and expend a sum not to exceed \$107,500 for cost of developing an airport in the Rumford-Mexico area?"
