STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-ONE

RESOLVE, Appropriating Funds for Regional Airport to Service Augusta, Waterville and Surrounding Areas.

Regional airport; appropriation. Resolved: That there is appropriated from the Unappropriated Surplus of the General Fund a sum not in excess of \$2,532,500 for a regional airport to service Augusta, Waterville and surrounding areas to be located in the Sidney area. The expenditure shall be under the supervision of the Aeronautics Commission, subject to the approval of the Governor and Council. Such expenditure as may be authorized by this resolve shall be contingent upon the fact that not more than 50% of the project cost shall be paid for by funds herein appropriated. It is the intent of the Legislature to so limit the use of state funds as to require that federal funds and other funds shall finance 50% of the cost of the project; and be it further

Resolved: That this appropriation shall not lapse, but shall remain a continuing carrying account until the purposes of this resolve are accomplished.
