### STATE OF MAINE

# IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-ONE

AN ACT to Permit the Town of Moscow to Withdraw from School Administrative District No. 13.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Withdrawal of Moscow authorized. Pursuant to action by the Town of Moscow in a special town meeting duly called and held on the first day of October, 1960, the withdrawal of the Town of Moscow from School Administrative District No. 13 is authorized, effective on the first day of June, 1961. Prior to that date, the Town of Moscow shall cause to be chosen a superintending school committee of not less than 3 members in accordance with the Revised Statutes of 1954, chapter 41, section 46, as amended, which shall after June 1, 1961, perform all the duties required by statute of the superintending school committee.
- Sec. 2. Property transferred to Moscow. The said superintending school committee of the Town of Moscow shall on June 1, 1961, or within 14 days thereafter, request in writing that the directors of School Administrative District No. 13 convey the title to such school real property and buildings and personal property, if any, as heretofore conveyed by the Town of Moscow to School Administrative District No. 13, and upon receipt of such request in writing, the directors of School Administrative District No. 13 shall forthwith make such conveyance to the Town of Moscow.
- Sec. 3. Operational expenses, Moscow's share. As its proportionate share of the budget assessed by School Administrative District No. 13 against the Town of Moscow for operational expenses of School Administrative District No. 13 for the fiscal year 1961-1962, prior to such withdrawal, the Town of

Moscow shall pay to School Administrative District No. 13, not later than September 1, 1961, its percentage of the amount due School Administrative District No. 13 for operational expenses incurred during the school year 1960-1961 and ending at the termination of school in 1961, less the amount which the Town of Moscow has paid to School Administrative District No. 13 towards the 1961-1962 budget.

- Sec. 4. Subsidy payment for Moscow. The Commissioner of Education shall apportion to the Town of Moscow its state subsidy as provided in the Revised Statutes of 1954, chapter 41, section 237-E, for the year 1960, deducting from the 1960 subsidy payment any sums due to School Administrative District No. 13 for its proportionate share of operational expenses incurred by School Administrative District No. 13 to the end of the school year 1960.
- **Sec. 5.** Directors representing Moscow. Upon the withdrawal of the Town of Moscow from School Administrative District No. 13, the duly elected directors representing the Town of Moscow, now serving on the Board of Directors of School Administrative District No. 13, shall no longer be members of the Board of Directors of School Administrative District No. 13.
- Sec. 6. Liability of Moscow. The Maine School District Commission shall have the power and authority to determine what sum or sums shall be due from the Town of Moscow to School Administrative District No. 13, and upon payment of said sum or sums by the Town of Moscow, the liability of the Town of Moscow to School Administrative District No. 13 shall cease.
