IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

AN ACT Eliminating Zones for Deer Hunting.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 37, § 91, amended. The first 8 paragraphs of section 91 of chapter 37 of the Revised Statutes, as revised, are repealed and the following enacted in place thereof:

‘There shall be an annual open season on deer during the month of November in each calendar year in the Counties of Androscoggin, Cumberland, Hancock, Kennebec, Knox, Lincoln, Oxford, Sagadahoc, Waldo, Washington and York. All the rest of the calendar year before and after the open season shall be a closed season on deer.

There shall be an open season on deer in each calendar year beginning the 21st day of October and ending the 30th day of November in the Counties of Aroostook, Penobscot, Somerset, Piscataquis and Franklin. All of the rest of the calendar year, either before or after the open season, shall be a closed season on deer in these counties.’

Sec. 2. R. S., c. 37, § 108, repealed and replaced. Section 108 of chapter 37 of the Revised Statutes, as revised, is repealed and the following enacted in place thereof:

‘Sec. 108. Open season. There shall be an annual open season on deer during the month of October in each calendar year in the Counties of Androscoggin, Cumberland, Hancock, Kennebec, Knox, Lincoln, Oxford, Sagadahoc, Waldo, Washington and York for the purpose of hunting deer with bow and arrow only.

There shall be an annual open season on deer in each calendar year beginning

the first day of October and ending the 20th day of October, in the Counties of Aroostook, Franklin, Penobscot, Piscataquis and Somerset, for the purpose of hunting deer with bow and arrow only.'

Sec. 3. R. S., c. 37, § 109, amended. The first sentence of section 109 of chapter 37 of the Revised Statutes, as revised, is repealed and the following enacted in place thereof:

'An archery license shall be issued by the commissioner to take deer under sections 108 to 112, the fee for which shall be \$4.25 for hunting deer by residents of this State and \$10.25 for hunting deer by nonresidents; except that such archery licenses shall also permit the hunting of such wild birds and animals which can be legally hunted beginning on the first Monday in October for a period beginning the first Monday in October and ending the 2nd Saturday thereafter.'
