IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

RESOLVE, to Reimburse Town of Greenville for Express Charges on Surplus Foods Distributed to Unorganized Territory.

Town of Greenville; reimbursed. Resolved: That there is appropriated to the Town of Greenville from the Unappropriated Surplus of the General Fund the sum of \$118.39 for the express charges paid by the town on surplus foods distributed to people in the unorganized territory.
