IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

AN ACT Increasing Salaries of the County Attorneys and the Assistant County Attorneys.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 254, amended. That part of the 2nd paragraph of section 254 of chapter 89 of the Revised Statutes, as repealed and replaced by section 7 of chapter 372 of the public laws of 1959, which relates to the salaries of the county attorney and assistant county attorney of Androscoggin County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$7,500; assistant county attorney, ~~\$3,200~~ \$5,200;'

Sec. 2. R. S., c. 89, § 254, amended. That part of the 3rd paragraph of section 254 of chapter 89 of the Revised Statutes, as last repealed and replaced by section 176 of chapter 417 of the public laws of 1961, which relates to the salaries of the county attorney and assistant county attorney of Aroostook County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$7,500; assistant county attorney, ~~\$3,000~~ \$5,200;'

Sec. 3. R. S., c. 89, § 254, amended. 'county attorney, ~~\$3,300~~ \$5,200;'

Sec. 16. R. S., c. 89, § 254, amended. That part of the 17th paragraph of section 254 of chapter 89 of the Revised Statutes, as repealed and replaced by section 7 of chapter 372 of the public laws of 1959 and as amended, which relates to salaries of county attorney and assistant county attorney of York County, is further amended to read as follows:

'county attorney, ~~\$3,700~~ \$7,500; assistant county attorney, ~~\$2,500~~ \$5,200;'

Sec. 17. Appropriation. There is appropriated from the General Fund to the Department of Attorney General the sum of \$40,575 for the fiscal year ending June 30, 1964 and the sum of \$54,100 for the fiscal year ending June 30, 1965 to provide for the increases in salaries of county attorneys and assistant county attorneys. The breakdown shall be as follows:
