STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

AN ACT Increasing Salary and Expenses of Reporter of Decisions.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 104, § 1, amended. The last sentence of section 1 of chapter 104 of the Revised Statutes is amended to read as follows:

'He shall receive an annual salary of ~~\$2,500~~ \$3,700.'

Sec. 2. R. S., c. 104, § 3, amended. The 3rd sentence of section 3 of chapter 104 of the Revised Statutes is repealed as follows:

'~~The reporter may retain out of said profits received by him the sum of \$500 on account of each volume of reports published by him for clerk hire, stationery, postage, expressage and incidental expenses.~~'

Sec. 3. R. S., c. 104, § 5, amended. Section 5 of chapter 104 of the Revised Statutes, as amended by section 2 of chapter 347 of the public laws of 1957, is further amended to read as follows:

'**Sec. 5. Reimbursement for expenses.** The reporter shall be reimbursed by the State for charges actually and reasonably incurred by him for clerk hire, stationery, postage, expressage and incidental expenses, ~~to the extent that such charges exceed the amounts he is entitled to retain out of profits to pay the same pursuant to the provisions of section 3~~ but such reimbursement by the State shall not exceed ~~\$2,000~~ \$3,000 in any one year.'

Sec. 4. Appropriation. There is appropriated from the General Fund to the Supreme Judicial and Superior Courts the sum of \$1,900 for the fiscal year end-

ing June 30, 1964 and the sum of \$2,200 for the fiscal year ending June 30, 1965 to carry out the purposes of this act. The breakdown shall be as follows:
