STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

RESOLVE, for Laying of the County Taxes for the Years Nineteen Hundred Sixty-three and Nineteen Hundred Sixty-Four.

Emergency preamble. Whereas, the several counties hereinafted named have certain expenses and liabilities which must be met as they become due; and

Whereas, the several counties have no source of revenue except the taxes hereinafter mentioned; and

Whereas, it is necessary that the taxes for the year 1963 hereinafter mentioned be immediately assessed, in order to provide the required revenue for the several counties; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

County taxes apportioned. Resolved: That the sums appearing opposite to the names of the counties in the following schedule are hereby granted as a tax on each county respectively to be appropriated, assessed, collected and applied to the purpose of paying the debts and necessary expenses of the same and for other purposes of law, for the years 1963 and 1964.
