## STATE OF MAINE SENATE 101st LEGISLATURE FIRST SPECIAL SESSION

SENATE AMENDMENT "A" to H.P.1164, L. D. 1674, Bill, "An Act Appropriating Funds for Grants-in-Aid for Construction of Municipal Sewage

Treatment Facilities and Relating to Issuance of Water and Sewer

System Revenue Bonds by Municipalities."

Amend said Bill in that part designated "Sec. 15-A." of section 6 by striking out all of subsection I and inserting in place thereof the following underlined subsection I:

'I. To acquire, construct, reconstruct, improve, extend, enlarge, equip, repair, maintain and operate any revenue producing municipal facility consisting of a water system or part thereof or a sewer system or part thereof within or without or partly within and partly without the corporate limits of the municipality;'

Further amend said Bill in that part designated "Sec. 15-A." of section 6 by striking out all of the underlined subsection IV and by renumbering subsections V to XIII to be subsections IV to XII.

Further amend said Bill by adding at the end of subsection X of that part designated "Sec. 15-A." of section 6 the following underlined words and punctuation:

'when highways maintained by the State are affected, the municipality shall be subject to the same statutory provisions applicable to those corporations authorized to lay their pipes and conduits in the public ways;'

Further amend said Bill in the next to the last sentence of subsection II of that part designated "Sec. 15-B." of section 6 by adding after the underlined word "Bonds" the underlined punctuation and words:

', except bonds for water system purposes,'

Further amend said Bill by striking out all of the 2nd underlined sentence of that part designated "Sec. 15-C." of section 6 and inserting in place thereof the following underlined sentence:

'Such rates, fees and charges, except rates, fees and charges for water system purposes, shall not be subject to supervision or regulation by any other commission, board, bureau or agency of the municipality or of the State and the municipality shall charge and collect the rates, fees and charges so fixed or revised.'; and by striking out all of the last 2 underlined sentences of section 15-C.

Further amend said Bill in that part designated "Sec. 15-D." of section 6 by striking out all of the underlined subsection II and by renumbering subsection III to be subsection II.
