RESOLVE, to Provide Funds for Additional Personnel for the Southern Maine Vocational-Technical Institute at South Portland.

**Additional personnel; Southern Maine Vocational-Technical Institute. Re-
solved:** That there be appropriated to the State Department of Education from the General Fund the sum of \$33,415 for the fiscal year ending June 30, 1966 and the sum of \$60,627 for the fiscal year ending June 30, 1967 for additional personnel at the Southern Maine Vocational-Technical Institute at South Portland as follows:

STATEMENT OF FACTS

This resolve is to appropriate funds for needed additional personnel at the Southern Maine Vocational-Technical Institute at South Portland. A full-time Librarian is necessary for the Library to serve properly its functions in a school. The added faculty will permit enrolling more students; at present less than half of those applying can be accepted. As the school has grown and continues to grow, the work load is excessive for the present staff. Hence the request for an Accountant, Building Custodian and Clerk Typist. The night school trade oriented program is in big demand, but enrollment is limited by lack of administrative time. Requested is a person to direct the night school and also serve as the Dean of the Faculty. The Mechanical Technology personnel are needed to implement a new course by that name to be started if the Governor's recommended budget for a laboratory building is approved by the Legislature.
