AN ACT Increasing Salaries of County Attorneys and Assistant County Attorneys.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 30, § 2, amended. That part of the 2nd paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney and assistant county attorney of Androscoggin County, is amended to read as follows:

'county attorney, ~~\$5,000~~ \$5,500; assistant county attorney, ~~\$3,500~~ \$4,000;'

Sec. 2. R. S., T. 30, § 2, amended. That part of the 3rd paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney and assistant county attorney of Aroostook County, is amended to read as follows:

'county attorney, ~~\$4,500~~ \$5,000; assistant county attorney, ~~\$3,500~~ \$4,000;'

Sec. 3. R. S., T. 30, § 2, amended. That part of the 4th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney, first assistant county attorney and second assistant county attorney of Cumberland County, is amended to read as follows:

'county attorney, ~~\$6,500~~ \$7,000; first assistant county attorney, ~~\$5,000~~ \$5,500; second assistant county attorney, ~~\$4,500~~ \$5,000;'

Sec. 4. R. S., T. 30, § 2, amended. That part of the 5th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Franklin County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 5. R. S., T. 30, § 2, amended. That part of the 6th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Hancock County, is amended to read as follows:

'county attorney, ~~\$4,500~~ \$5,000;'

Sec. 6. R. S., T. 30, § 2, amended. That part of the 7th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney and assistant county attorney of Kennebec County, is amended to read as follows:

'county attorney, ~~\$5,000~~ \$5,500; assistant county attorney, ~~\$3,500~~ \$4,000;'

Sec. 7. R. S., T. 30, § 2, amended. That part of the 8th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Knox County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 8. R. S., T. 30, § 2, amended. That part of the 9th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Lincoln County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 9. R. S., T. 30, § 2, amended. That part of the 10th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Oxford County, is amended to read as follows:

'county attorney, ~~\$4,500~~ \$5,000;'

Sec. 10. R. S., T. 30, § 2, amended. That part of the 11th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney and assistant county attorney of Penobscot County, is amended to read as follows:

'county attorney, ~~\$5,500~~ \$6,000; assistant county attorney, ~~\$4,250~~ \$4,750;'

Sec. 11. R. S., T. 30, § 2, amended. That part of the 12th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Piscataquis County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 12. R. S., T. 30, § 2, amended. That part of the 13th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Sagadahoc County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 13. R. S., T. 30, § 2, amended. That part of the 14th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Somerset County, is amended to read as follows:

'county attorney, ~~\$4,500~~ \$5,000;'

Sec. 14. R. S., T. 30, § 2, amended. That part of the 15th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Waldo County, is amended to read as follows:

'county attorney, ~~\$4,000~~ \$4,500;'

Sec. 15. R. S., T. 30, § 2, amended. That part of the 16th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salary of the county attorney of Washington County, is amended to read as follows:

'county attorney, ~~\$4,500~~ \$5,000;'

Sec. 16. R. S., T. 30, § 2, amended. That part of the 17th paragraph of section 2 of Title 30 of the Revised Statutes, which relates to the salaries of the county attorney and assistant county attorney of York County, is amended to read as follows:

'county attorney, ~~\$5,000~~ \$5,500; assistant county attorney, ~~\$3,500~~ \$4,000;'

Sec. 17. Appropriation. There is appropriated from the General Fund to the Department of Attorney General the sum of \$5,750 for the fiscal year ending June 30, 1966 and the sum of \$11,500 for the fiscal year ending June 30, 1967 to provide for the increases in salaries of county attorneys and assistant county attorneys.

The breakdown shall be as follows:
