SENATE AMENDMENT "A" to H. P. 673, L. D. 900, Bill, "An Act to Authorize the Establishment of an Area State Operated Vocational Technical High School in York County and the Issuance of Not Exceeding One Million One Hundred and Fifteen Thousand Dollar Bonds of the State of Maine for the Financing Thereof."

Amend said Bill by striking out all of the Title and inserting in place thereof the following: 'An Act to Authorize the Establishment of a Regional Vocational Education Center or Centers in York County and the Issuance of Not Exceeding Five Hundred Thousand Dollar Bonds of the State of Maine for the Partial Financing Thereof.'

Further amend said Bill in the 18th line by striking out the words "vocational technical high schools" and inserting in place thereof the words 'regional vocational education centers'; and by striking out in the 21st line the words "vocational high schools" and inserting in place thereof the words 'regional vocational education centers'; and by striking out in the 27th line the words "vocational technical high school" and inserting in place thereof the words 'regional vocational education center or centers'

Further amend said Bill by striking out all of section 1 and inserting in place thereof the following:

'Sec. 1. Regional Vocational Education Center or Centers.
Subject to the submission by an eligible public school agency in York County of a plan meeting state board approval, the State Board of Education will assist in the establishment and operation of regional vocational education center or centers in accordance with Legislative Document No. 44 of the 102nd Legislature.'

Further amend said Bill, in section 2, by striking out in the 4th line the figure "\$1,115,000" and inserting in place thereof the figure '\$500,000'; and by striking out in the 5th and 6th lines the words "vocational technical high school" and inserting in place thereof the words 'regional vocational education center or centers'

Further amend said Bill, in section 9, by striking out in the 5th and 6th lines the words "constructing a State Vocational Technical High School in York County" and inserting in place thereof the words 'assisting in the construction of a regional vocational education center or centers in York County'

Further amend said Bill by striking out all of the 2nd paragraph of the Referendum and inserting in place thereof the following:

' "Shall 'An Act Providing a Bond Issue in the Amount of Five Hundred Thousand Dollars for a Regional Vocational Education Center or Centers in York County' passed by the 102nd Legislature, be accepted?" '
