STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-SEVEN

AN ACT Appropriating Funds for Capital Construction and Equipment at the Madawaska Airport, Aroostook State College, Gorham State College, Central Maine Vocational-Technical Institute, Southern Maine Vocational-Technical Institute, Bureau of Public Improvements and Stevens Training Center.

Emergency preamble. Whereas, acts of the Legislature do not become effective until 90 days after the Legislature unless enacted as emergencies; and

Whereas, the said 90 day period will not terminate until after the beginning of the next fiscal year; and

Whereas, it is to the best interests of the State to take advantage of current construction prices; and

Whereas, it is essential that construction be started at the earliest possible date; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Appropriation. There is appropriated from the Unappropriated Surplus of the General Fund not otherwise appropriated the sum of \$456,600 for the fiscal year ending June 30, 1967, to be expended under the direction and supervision of the Bureau of Public Improvements. The breakdown of expenditures shall be as follows:

Unencumbered balances. Any unencumbered balances remaining at June 20, 1967 shall not lapse but shall be carried forward until June 30, 1970.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.
