# IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-SEVEN

#### AN ACT Relating to the Practice of Hairdressing and Beauty Culture.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. R. S., T. 32, § 1551, sub-§ 1, amended. Subsection 1 of section 1551 of Title 32 of the Revised Statutes is amended to read as follows:
- r. Practice of hairdressing and beauty culture. The practice of, teaching of or demonstration of hairdressing and beauty culture shall mean the engaging by any person for hire or reward in any one or more of the following practices:

The application of the hands or of mechanical or electrical apparatus with or without cosmetic preparations, tonics, lotions, creams, antiseptics or clays to massage, cleanse, stimulate, manipulate, exercise or otherwise to improve or to beautify the scalp, face, neck, shoulders, arms, hands or to manicure the fingernails of any person; or to arrange, dress, curl, wave, cleanse, cut, singe, bleach, color or similarly treat the hair of any person, or to arrange, dress, curl, wave, cleanse, cut, singe, bleach, color or similarly treat a wig, wiglet or hair piece made of human hair, animal hair or synthetics.

Sec. 2. R. S., T. 32, § 1551, sub-§ 3, amended. Subsection 3 of section 1551 of Title 32 of the Revised Statutes is amended by adding at the end thereof a new sentence to read as follows:

The term "demonstrator" shall not include one who performs such demonstrations solely for the benefit of persons who have a certificate to practice hairdressing and beauty culture under this chapter.

Sec. 3. R. S., T. 32, § 1651, amended. Section 1651 of Title 32 of the Revised Statutes is amended by adding at the end thereof the following:

The practice of hairdressing and beauty culture shall be done only in a licensed shop, except in the following situations:

- 1. Patients. When done upon patients in hospitals or nursing homes;
- 2. Inmates. When done upon inmates of institutions;
- 3. Household. When done by a member of a household to immediate member of their family;
  - 4. Invalids. When done upon invalids in their place of residence.
