STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-SEVEN

AN ACT Increasing Salaries of the Sheriffs of the Several Counties.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 30, § 2, amended. That part of the 2nd paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the sheriff of Androscoggin County, as last repealed and replaced by section 58 of chapter 513 of the public laws of 1965, is amended to read as follows:

sheriff, \$5,900 **\$8,000**;
