### **AN ACT Increasing Salaries of the Sheriffs of the Several Counties.**

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., T. 30, § 2, amended.** That part of the 2nd paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the sheriff of Androscoggin County, as last repealed and replaced by section 58 of chapter 513 of the public laws of 1965, is amended to read as follows:

sheriff, ~~\$5,900~~ \$8,000;

**Sec. 2. R. S., T. 30, § 2, amended.** That part of the 3rd paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the sheriff of Aroostook County is amended to read as follows:

sheriff, ~~\$5,500~~ \$7,000;

**Sec. 3. R. S. T. 30, § 2, amended.** That part of the 4th paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the sheriff of Cumberland County is amended to read as follows:
