SENATE AMENDMENT "B" to S.P. 60, L.D. 168, Bill, "AN ACT  
Creating County Commissioner Districts."

Amend said Bill in section 1 by striking out all of the  
4th underlined sentence (same in L.D.) and inserting in place  
thereof the following underlined sentence:

'Districts shall be composed so every municipality, plantation  
and unorganized territory in the district must border on at  
least one other municipality or plantation or unorganized  
territory in the district, unless the district is composed of  
one municipality or precincts thereof.'

Further amend said Bill in subsection 2 of section 2 by  
striking out in the 4th line (same in L.D.) the underlined words  
and punctuation "Academy Grant,"; and by striking out in the 9th  
and 10th lines (10th line in L.D.) the words "North Yarmouth" and  
inserting in place thereof the underlined words 'North Yarmouth  
Academy Grant'

Further amend said Bill in subsection 10 of section 2 by  
striking out in the 7th line (same in L.D.) the underlined comma  
which appears after the underlined words "Indian Purchase"

Further amend said Bill in subsection 11 of section 2 by  
striking out all of the 4th paragraph (same in L.D.) and inserting  
in place thereof the following:

'Commissioner District number 3 consisting of the munici-  
palities and unorganized territory of Abbott, Big Squaw, Blanchard  
Plt., Bowdoin College Grant, East and West, Burbank, Chesuncook,  
Cove Point, Days Academy Grant, Eagle Lake, East Middlesex Canal  
Grant, Elliotsville Plt., Frenchtown, Greenville, Guilford,  
Harfords Point, Kineo Twp., Kingsbury Plt., Lily Bay, Little Squa-  
r, Lobster, Monson, Mt. Katahdin, Rainbow, Sandbar Tract, Shirley,  
Soper Mt. Wellington, Willimantic, TA2R13, & R14, R11, R12, TXR14,  
T4R9, 5R9, 7R9, NWP, T1R11, R12, R13, R14, T2R12, R13, T3R10, R11,  
R12, R13, T4R10, R11, R12, R13, R14, R15, T5R10, R11, R12, R14,  
R15, T6R9, R10, R11, R12, R13, R14, R15, T7R9, R10, R11, R12, R13,  
R14, R15, T8R9, R10, R11, R14, R15, T9R9, R10, R11, R12, R13, R14,  
R15, T10R9, R10, R11, R12, R13, R14 and R15 WELS.'

Further amend said Bill in section 2 by striking out all of subsection 13 (same in L.D.) and inserting in place thereof the following:

'13. Somerset County. Somerset County shall be divided into the following 3 districts:

Commissioner District number one consisting of the municipalities and unorganized territory of Alder Brook, Anson, Appleton, Athens, Attean Pond, Bald Mtn. (T2R3), Bald Mtn. (T4R3), Bigelow, Big 6, Big 10, Big W, Bingham, Blake Gore, Bowtown, Bradstreet, Brassua, Brighton Plt., Cambridge, Caratunk Plt., Carrying Place, Chase Stream, Comstock, Concord, Cornville, Dale Brook, Dead River, Dennistown Plt., East Moxie, Elm Stream, Embden, Flagstaff, Forsyth, Hammond, Harmony, Hartland, Highland Plt., Hobbstown, Holeb, Indian Stream, Jackman, Johnson Mtn., King & Bartlett, Lexington, Little W., Long Pond, Lower Enchanted, Mayfield, Misery, Misery Gore, Moose River, Moscow, Moxie Gore, New Portland, Palmyra, Parlin Pond, Pierce Pond, Pittston Academy Grant, Pleasant Ridge Plt., Plymouth, Prentiss, Ripley, Rockwood Strip, Russell Pond, St. Albans, St. John, Sandbar Tract, Sandwich Academy Tract, Sandy Bay, Sapling, Seboomook, Soldiertown, Squaretown, Taunton & Raynham Tract, Ten Thousand Acre Tract, The Forks Plt., Thorndike, Tomhegan, Upper Enchanted, West Forks Plt., West Middlesex Canal Grant, T1R3, 3R4, 3R5, 5R6, 5R7 BKPWR, T4R5 NBKP, T4R17, 5R17, 5R18, 5R19, 5R20, 6R17, 6R18, 7R16, 7R17, 7R18, 7R19, 8R16, 8R17, 8R18, 8R19, 9R16, 9R17, 9R18, 10R16 WELS.

Commissioner District number 2 consisting of the municipalities of Fairfield, Madison, Mercer, Norridgewock, Smithfield, Solon and Starks.

Commissioner District number 3 consisting of the municipalities of Canaan, Detroit, Pittsfield and Skowhegan.
