Amend said Bill in the 10th line of section 2 (9th line of section 2 of L. D. 668) by inserting after the words "fees for" the underlined word '<u>such</u>'

Further amend said Bill in the llth line of section 2 (10th of section 2 of L. D. 668) by striking out the figures and words "\$15 \$50 may be charged" and inserting in place thereof the following: '\$15-may-be-eharged those set forth in the following schedule for the types of establishments therein listed respectively may be charged, namely:
