### AN ACT Increasing Salaries of Clerks of Court.

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., T. 30, § 2, amended.** That part of the 2nd paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the clerk of courts of Androscoggin County, as last amended by section 1 of chapter 414 of the public laws of 1967, is further amended to read as follows:  
clerk of courts, ~~\$8,400~~ \$11,600;

**Sec. 2. R. S., T. 30, § 2, amended.** That part of the 3rd paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salary of the clerk of courts of Aroostook County, is amended to read as follows:  
clerk of courts, ~~\$6,000~~ \$8,000; deputy clerk of courts, \$5,500;

**Sec. 3. R. S., T. 30, § 2, amended.** That part of the 4th paragraph of section 2 of Title 30 of the Revised Statutes which relates to the salaries of the clerk of courts and deputy clerk of courts of Cumberland County, as last amended by section 1 of chapter 414 of the public laws of 1967, is further amended to read as follows:
