STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-NINE

AN ACT Increasing Borrowing Capacity of School Administrative District No. 14.

Be it enacted by the People of the State of Maine, as follows:

School Administrative District No. 14; borrowing capacity increased. The school directors of School Administrative District #14 are authorized and empowered to borrow the sum of \$300,000 in the aggregate, notwithstanding any limitations contained in the Revised Statutes.

STATEMENT OF FACTS

S.A.D. 14 (Town of Danforth) having suffered 3 devastating fires in an 11-year period, the most recent of which destroyed the gymnasium building, find themselves in the following financial situation.

The state valuation for S.A.D. 14 is \$1,370,000, of which their authorized borrowing capacity is 12½% of State valuation or \$171,250. Of the authorized borrowing capacity, approximately \$80,000 is now obligated to rebuild buildings from a previous fire and for the replacement of a school bus. Further than this, the voters of S.A.D. 14 approved an additional bond issue in the amount of \$125,000 to build an industrial arts shop, science laboratory and 2 additional classrooms. The present outstanding debt, plus the authorized Bond Issue of \$125,000, places S.A.D. 14 in excess of its authorized debt limit by approximately \$35,000.

In addition to this dilemma, S.A.D. 14 must now replace the gymnasium, which was lost by fire December last, at an estimated cost of \$125,000. S.A.D. 14 expects to receive approximately \$30,000 from insurance coverage, and, hopefully, an additional \$25,000 by a special Legislative resolve, leaving a balance to be raised by the district of approximately \$70,000.

Taking the already outstanding debt of approximately \$80,000, adding the \$125,000 bond issue already authorized for an industrial arts shop, science lab and classrooms, and \$70,000 additional for rebuilding of the gymnasium, it is necessary, therefore, to ask the Legislature to expand the borrowing authority of S.A.D. 14 to \$300,000 to cover the necessary rebuilding.
