HOUSE AMENDMENT " A " to H. P. 1071, L. D. 1252, Bill,
"AN ACT to Correct Errors and Inconsistencies in the Maine Insurance
Code."

Amend said Bill by inserting after section 1, a new
section, as follows: (Same in L.D.)

'Sec. 1-A. R. S., T. 24-A, §12, repealed and replaced.

Section 12 of Title 24-A of the Revised Statutes is repealed and
the following enacted in place thereof:

§ 12. General penalty

1. Persons. Any person knowingly violating any provision
of this Title for which a different penalty consisting of fine
or imprisonment, or both, is not provided by a provision of this
Title or other applicable laws of this State, shall be punished
by a fine of not more than \$1,000 or by imprisonment for less than
one year, or by both.

2. Corporations. Except, that if the violator is a corporation
or entity other than an individual, the fine shall be not more than
\$3,000 for each violation. Any director, officer, manager, employee
or representative of a corporation or other entity shall be punished
by a fine and imprisonment as provided in subsection 1 for knowingly
authorizing or knowingly participating in any violation.

Further amend said Bill by inserting after section 27-A, a new section, as follows: (same in L.D.)

'Sec. 27-B. R. S., T. 24-A, §1513, sub-§3, amended. Sub-section 3 of section 1513 of Title 24-A of the Revised Statutes is amended to read as follows:

3. Any regular salaried officer or employee of an authorized insurer rendering assistance to or on behalf of a licensed agent or broker, if such officer or employee devotes substantially all of his time to activities other than the solicitation of applications for insurance or annuity contracts, and receives no commission or other compensation directly dependent upon the amount of business obtained; except that a service representative shall be licensed as an agent as when required by section 1507.'

Further amend said Bill by striking out all of section 62 (same in L.D.)

Further amend said Bill by renumbering sections 63 to 65 to be sections 62 to 64.
