HOUSE AMENDMENT "A" to H. P. 1030, L. D. 1339,  
Bill, "AN ACT Providing for Implied Consent Law for Operators  
of Motor Vehicles."

Amend said Bill in that part designated "§ 1312" of  
section 1 by striking out in the 9th line (8th line in L.D.)  
the underlined words "or drugs" and by striking out in the 10th  
line (9th line in L.D.) the underlined words "or drugs"

Further amend said Bill in subsection 2 of that part  
designated "§ 1312" of section 1 by striking out in the 7th line  
(6th line in L.D.) the underlined words "or drugs"; and by striking  
out in the 8th line (7th line in L.D.) the underlined words "or  
drugs"; and by striking out in the 10th and 11th lines (9th line  
in L.D.) the underlined words "in the same manner and under the  
same conditions" and inserting in place thereof the underlined  
words 'by the same procedure'

Further amend said Bill in subsection 3 of that part  
designated "§ 1312" of section 1 by striking out in the 5th line  
(4th and 5th lines of L.D.) the underlined words "in the same manner  
and under the same conditions" and inserting in place thereof the  
underlined words 'by the same procedure'; and by striking out in the  
7th line (6th line in L.D.) the underlined word "permit" and  
inserting in place thereof the underlined word 'privilege'

Further amend said Bill in paragraph A of subsection 6 of  
that part designated "§ 1312" of section 1 by striking out in the

5th line (4th line in L.D.) the underlined words "or drugs"; and by striking out in the 6th line (5th line in L.D.) the underlined words "or drugs"; and by striking out in the 6th line (5th line in L.D.) of paragraph B the underlined words "or drugs" and by striking out in the 11th line (9th line of L.D.) the underlined words "or drugs"; and by striking out in the 5th line (4th line in L.D.) of paragraph C the underlined words "or drugs" and by striking out in the 7th line (6th line in L.D.) the underlined words "or drugs"; and by striking out in the 4th line (3rd line in L.D.) of paragraph D the underlined words "or drugs".

Further amend said Bill in that part designated "§ 1312" of section 1 by striking out all of subsection 8 (same in L.D.) and inserting in place thereof the following:

'8. Liability. No physician, registered nurse, or person certified by the Department of Health and Welfare, shall be held liable in damages or otherwise for any act done or omitted to be done in performing the act of collecting or withdrawing specimens of blood at the request of a law enforcement officer pursuant to this section. No person administering and conducting chemical tests of blood, breath or urine shall be held liable in damages or otherwise for any act done or omitted to be done in administering or conducting said tests at the request of a law enforcement officer pursuant to this section.'

Further amend said Bill in paragraph A of subsection 11 of that part designated "§ 1312" of section 1 by striking out in the 8th, 12th, 20th, 23rd and 34th lines (7th, 10th, 16th, 18th,

and 26th lines of L.D.) the underlined words "this paragraph" and inserting in place thereof the underlined words 'paragraph A of this subsection'

Further amend said Bill in paragraph B of subsection 11 of that part designated "§ 1312" of section 1 by striking out in the 11th, 15th, 23rd, 28th, 36th, 45th, 54th and 55th, and 58th lines (9th, 12th, 18th, 21st, 28th, 35th, 42nd and 45th lines) the underlined words "this paragraph" and inserting in place thereof the underlined words 'paragraph B of this subsection'

Further amend said Bill in paragraph C of subsection 11 of that part designated "§ 1312" of section 1 by inserting after the underlined letter "B" in the 2nd line (same in L.D.) the underlined words 'of this subsection'
