SENATE AMENDMENT "A" to H.P. 1031, L.D. 1361, Bill, "AN ACT to Provide Mandatory Penalties for Commission of a Crime with a Dangerous Weapon."

Amend said Bill, in the Title, by striking out the words "Dangerous Weapon" and inserting in place thereof the words 'Firearm'

Further amend said Bill By striking out all of that part designated "§2" of section 1 and inserting in place thereof the following:

'§2. Abduction of women while armed with firearm

Whoever, if armed with a firearm, takes a woman unlawfully and against her will and by force, menace or duress compels her to marry him or any other person or to be defiled shall be punished by imprisonment for any term of years. Whoever, if armed with a firearm, takes a woman with intent by such means to compel her to do so shall be punished by imprisonment for not less than one nor more than 10 years.

The imposition or execution of a sentence for a violation of this section shall not be suspended and probation shall not be granted.'

Further amend said Bill by striking out all of the 4th line of section 2 (3rd line in L.D.) and inserting in place thereof the following: '§163-A. Firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the word 'firearm'; and by striking out in the 8th line (7th line of L.D.) the underlined words "less than 10 nor"

Further amend said Bill by striking out in the 4th line of section 4 (3rd line of L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 11th line (9th line of L.D.) the underlined words "less than 2 nor"

Further amend said Bill by striking out in the 3rd line of section 5 (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 4th line (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 7th line (6th and 7th lines of L.D.) the underlined words "less than 2 nor"

Further amend said Bill by striking out in the 3rd line of section 6 (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 4th line (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 9th line (8th line of L.D.) the underlined figure "2" and inserting in place thereof the underlined word 'one'

Further amend said Bill by striking out in the 3rd line of section 8 (same in L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 4th line (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by striking out in the 4th line of section 11 (3rd line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 11th and 12th lines (10th line of L.D.) the underlined words "less than 5 nor"

Further amend said Bill by striking out in the 4th line of section 12 (same in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 5th line (4th line in L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by striking out in the 4th line of section 13 (3rd line of L.D.) the underlined words "dangerous weapons" and inserting in place thereof the underlined word 'firearms'; and by striking out in the 7th line (5th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 8th line (7th in L.D.) the underlined words "less than 4 nor"

Further amend said Bill by striking out in the 3rd line of section 14 (same in L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 5th and 11th line (4th, 5th and 9th lines of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 19th line (15th line of L.D.) the underlined figure and word "5 years" and inserting in place thereof the underlined words 'one year'

Further amend said Bill by striking out in the 4th line of section 15 (3rd in L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by striking out in the 4th and 5th lines of section 16 (3rd and 4th lines of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 9th line (7th line of L.D.) the underlined words "less than 10 nor"

Further amend said Bill by striking out in the 4th line of section 17 (3rd line of L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'; and by striking out in the 10th line (8th line of L.D.) the underlined figure and word "10 years" and inserting in place thereof the underlined words 'one year'

Further amend said Bill by striking out in the 4th line of section 20 (3rd line of L.D.) the underlined words "Dangerous weapon" and inserting in place thereof the word 'Firearm'; and by striking out in the 5th line (4th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by striking out in the 4th and 5th lines of section 21 (3rd and 4th lines of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the word 'firearm'; and by striking out in the 10th line (8th line of L.D.) the underlined figure and word "10 years" and inserting in place thereof the underlined words 'one year'

Further amend said Bill by striking out in the 4th and 5th lines of section 22 (3rd and 4th lines of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by adding at the end of section 24 the following:

'3. Firearm. "Firearm" shall include any pistol, revolver, rifle, shotgun, machinegun, automatic and semi-automatic rifle or other firearms the term is commonly used, or any gun, device or instrument in the nature of a weapon from which may be fired or projected any solid projectile or slug, pellet, missile or bullet or any gas, vapor or other nocuous thing by means of a cartridge or shell or by the action of any explosive or the igniting of flammable or explosive substances; or any other instrument that has the appearance of a firearm even though not capable of discharging a projectile.'

Further amend said Bill by striking out in the 4th line of section 25 (3rd line of L.D.) the underlined words "Dangerous Weapon" and inserting in place thereof the underlined word 'Firearm'; and by striking out in the 9th line (7th line of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the underlined word 'firearm'

Further amend said Bill by striking out in the 4th and 5th lines of section 26 (3rd and 4th lines of L.D.) the underlined words "dangerous weapon" and inserting in place thereof the word 'firearm'; and by striking out in the 9th line (7th and 8th lines of L.D.) the underlined words "less than 10 nor"
