HOUSE AMENDMENT " A " to SENATE AMENDMENT " C " to S. P. 449,  
L. D. 1483, Bill, "AN ACT Making Supplemental Appropriations for  
the Expenditures of State Government and for Other Purposes  
for the Fiscal Years Ending June 30, 1970 and June 30, 1971."

Amend said Amendment by inserting after the 13th line  
the following:

'Further amend said Bill in that part designated "Section A"  
by striking out under the caption "FINANCE AND ADMINISTRATION,  
DEPARTMENT OF" the following paragraph:

"Bureau of Public Improvements

Repairs and Minor Improvements

All Other	650,000	650,000

program"

and inserting in place thereof the following paragraph:

'Bureau of Public Improvements

Repairs and Minor Improvements

All Other	150,000	650,000

Unappropriated Surplus)'

and by striking out all of the last 2 lines which read as follows:

"Total Department of Finance and Administration	664,000	650,000"

and inserting in place thereof the lines:

'Total Department of Finance and Administration	164,000	650,000 '
--	---------	-----------

Further amend said Amendment by striking out all of the 18th line from the end and inserting in place thereof the following line:

'inserting in place thereof 'Personal Services 2,475,000 2,671,000 '

Further amend said Amendment by striking out all of the 14th line from the end and inserting in place thereof the following line:

'and inserting in place thereof 'Total State Employees 2,475,000 2,671,0

Further amend said Amendment by striking out all of the 8th, 9th and 10th lines from the end and inserting in place thereof the following lines:

'Total - All Appropriations 12,521,109 24,883,368

Amounting to \$12,521,109 for the fiscal year ending June 30, 1970 and \$24,883,368 for the fiscal year ending June 30, 1971.'
