HOUSE AMENDMENT " B " to H. P. 1231, L. D. 1564, Bill, "AN ACT Relating to Salaries of Jury Commissioners and County Officers in the Several Counties of the State and Court Messenger of Cumberland County."

Amend said Bill by striking out in section 1 the paragraph relating to Aroostook County and inserting in place thereof the following:

'Aroostook County: County commissioners, \$1,500, except that one member of the board, designated by the board as chief administrative officer, shall receive \$5,500; clerk of courts, ~~\$6,700~~ \$6,500; county attorney, \$6,500; assistant county attorney, \$4,500; county treasurer, \$3,500; sheriff, ~~\$5,500~~ \$6,500; register of deeds, northern district, \$5,500; southern district, \$5,500; judge of probate, ~~\$4,500~~ \$5,000; register of probate, \$4,000.'

Further amend said Bill by striking out in section 1 the paragraph relating to Piscataquis County and inserting in place thereof the following:

'Piscataquis County: County commissioners, ~~-\$1,710~~ \$1,300; chairman, ~~\$1,735~~ \$1,600; clerk of courts, ~~\$4,700~~ \$4,400; county attorney, \$5,000; county treasurer, ~~\$1,500~~ \$2,000; sheriff, ~~\$4,800~~ \$5,300; register of deeds, ~~\$4,700~~ \$5,000; judge of probate, ~~\$3,600~~ \$5,000; register of probate, ~~\$4,700~~ \$5,000.'

Further amend said Bill by striking out in section 1 the paragraph relating to Washington County and inserting in place thereof the following:

'Washington County: County commissioners, \$1,800; chairman, \$2,100; clerk of courts, ~~\$4,200~~ \$4,700; county attorney, \$5,000; county treasurer, ~~\$3,200~~ \$4,200; sheriff, ~~\$5,000~~ \$5,750; register of deeds, ~~\$4,200~~ \$4,700; judge of probate, ~~\$4,000~~ \$6,000; register of probate, ~~\$4,200~~ \$4,700.'

Further amend said Bill by striking out all of the paragraph in section 1 relating to York County and inserting in place thereof the following:

'York County: County commissioners, ~~\$2,250~~ \$2,480; clerk of courts, ~~\$7,000~~ \$7,700; deputy clerk of courts, ~~\$4,700~~ \$5,170; county attorney, \$6,500; assistant county attorney, \$4,500; county treasurer, ~~\$2,250~~ \$2,475; sheriff, ~~\$7,000~~ \$7,700; register of deeds, ~~\$6,000~~ \$6,600; judge of probate, ~~\$6,500~~ \$7,150; register of probate, ~~\$4,750~~ \$5,225.'
