

## STATE OF MAINE SENATE 104th LEGISLATURE

SENATE AMENDMENT "D" to H.P. 1272, L.D. 1601, Bill, "AN ACT Creating the Unclassified State Employees Salary Board and Revising The Salary Plan for Certain Unclassified State Officiala."

Amend said Bill, in the Title, by inserting at the end before the period the following ' and Increasing the Salaries of Justices and Judges of the Supreme, Superior and District Courts'

Further amend said Bill by adding at the end the following:

'Sec. 5. R.S., T. 4, §4, amended. The first sentence of section 4 of Title 4 of the Revised Statutes, as amended by section 5 of chapter 412 of the public laws of 1965 and by section 3 of chapter 476 of the public laws of 1967, is further amended to read as follows:

The Justices of the Supreme Judicial Court shall each receive an annual salary of \$20,000 \$22,000 and the Chief Justice of the Supreme Judicial Court shall receive an annual salary of \$21,500 \$23,500.

Sec. 6. R. S., T. 4, § 102, amended. The first sentence of section 102 of Title 4 of the Revised Statutes, as repealed and replaced by section 3 of chapter 513 of the public laws of 1965 and as amended by section 4 of chapter 476 of the public laws of 1967, is further amended to read as follows:

Each of the Justices of the Superior Court shall receive an annual salary of \$19,500 \$22,000.

Sec. 7. R.S., T. 4, §157, amended. The 4th sentence of section 157 of Title 4 of the Revised Statutes, as repealed and replaced by section 5 of chapter 513 of the public laws of 1965 and amended by section 6 of chapter 476 of the public laws of 1967, is further amended to read as follows:

Each judge shall receive an annual salary of \$15,000 \$17,000 and the Chief Judge shall receive an annual salary of \$16,000 \$18,000.

Sec. 8. Appropriation. There is appropriated from the General Fund the sum of \$79,265 to carry out the purposes of sections 5, 6 and 7 of this Act. The breakdown shall be as follows:
