

## STATE OF MAINE SENATE 104th LEGISLATURE FIRST SPECIAL SESSION

COMMITTEE AMENDMENT "A" to S.P. 603, L.D. 1778, Bill "AN ACT to Authorize Bond Issue in the Amount of \$24,835,000 for the Construction and Renovation of Higher Education Facilities at the University of Maine."

Amend said Bill in the Title by striking out the figure "\$24,835,000" and inserting in place thereof the figure '\$16,400,000'

Further amend said Bill in section 1 by striking out in the 6th line (5th line in L.D.) the figure "\$24,835,000" and inserting in place thereof the figure '\$16,400,000'

Further amend said Bill by striking out all of section 6 (same in L.D.) and inserting in place thereof the following:

'Sec. 6. Allocations from General Fund Bond Issue.
