COMMITTEE AMENDMENT " A " to H.P. 175, L.D. 233, Bill, "AN ACT to Authorize Bond Issue in the Amount of \$3,850,000 for Student Housing at Central Maine Vocational Technical Institute, Eastern Maine Vocational Technical Institute, Northern Maine Vocational Technical Institute, and the Maine Maritime Academy, Site Improvements at Washington County Vocational Technical Institute, Heating and Air Conditioning Shop and Laboratory at Southern Maine Vocational Technical Institute, Completion of School Building at Peter Dana Point Reservation and Tribal Halls for Penobscot and Passamaquoddy Reservations."

Amend said Bill in the Title by striking out in the 4th line (3rd line in L.D.) the words "Northern Maine" and inserting in place thereof the words 'Washington County'; and by striking out in the 9th line (7th line in L.D.) the words "Tribal Halls" and inserting in place thereof the words 'Multi-Purpose Buildings'

Further amend said Bill in section 6, under the heading "EDUCATION, DEPARTMENT OF" by striking out all of the 6th and 7th lines (same in L.D.) and inserting in place thereof the following:

'Washington County Vocational-Technical Institute

Dormitory

\$750,000'

Further amend said Bill in section 6 by striking out all of the last line under the heading "EDUCATION, DEPARTMENT OF" and inserting in place thereof the following:

'Total Department of Education	\$2,305,000'
--------------------------------	--------------

Further amend said Bill in section 6 by striking out all of the 3 lines under the heading "INDIAN AFFAIRS, DEPARTMENT OF" and inserting in place thereof the following:

'Penobscot & Passamaquoddy Reservations	
Multi-Purpose Buildings	<u>\$50,000</u>
Total Department of Indian Affairs	\$50,000'

Further amend said Bill in section 8 by striking out in the 4th line (3rd line in L.D.) the words "Northern Maine" and inserting in place thereof the words 'Washington County'; and by striking out in the 9th line (7th and 8th lines in L.D.) the words "Tribal Halls" and inserting in place thereof the words 'Multi-Purpose Buildings'

#### Statement of Fact

The purpose of this amendment is to:

1. Change dormitory for Northern Maine Vocational Institute to dormitory for Washington County Vocational Institute and change the appropriation from \$650,000 to \$750,000.
2. Change tribal halls for the Indian reservations to multi-purpose buildings and change the appropriation from \$150,000 to \$50,000.
