STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SEVENTY-ONE

AN ACT Relating to the Time of Commencement and Duration of School
Administrative District Meetings Held in Member Municipalities.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 20, § 225, sub-§ 2, ¶ A, amended. Paragraph A of subsection 2 of section 225 of Title 20 of the Revised Statutes, as amended by section 2 of chapter 295 of the public laws of 1967, is further amended by adding at the end a new sentence to read as follows:

The warrant shall specify the time of commencement and duration of the meeting or election.

Sec. 2. R. S., T. 20, § 225, sub-§ 2, ¶ C, amended. Paragraph C of subsection 2 of section 225 of Title 20 of the Revised Statutes, as amended, is further amended by adding a new sentence at the end of the first sentence to read as follows:

The notice shall specify the time of commencement and duration of the meeting or election.

Sec. 3. R. S., T. 20, § 225, sub-§ 2, ¶ G, amended. Paragraph G of subsection 2 of section 225 of Title 20 of the Revised Statutes is amended to read as follows:

G. Except for the time of commencement and duration of the meeting, ~~The~~ the voting at meetings held in towns shall be held and conducted in accordance with Title 30, sections 2061 to 2064, even though the town has not accepted the provisions of said section 2061.

Sec. 4. R. S., T. 20, § 225, sub-§ 2, ¶ H, amended. Paragraph H of subsection 2 of section 225 of Title 20 of the Revised Statutes, is amended to read as follows:

H. Except for the time of commencement and duration of meetings, ~~The~~ the voting at meetings in cities shall be held and conducted in accordance with Title 21.

STATEMENT OF FACT

The purpose of this bill is to require the School Administrative District Directors to set the hour when member municipalities shall meet and to further require the Directors to establish the duration of such meetings in order to achieve uniformity between the meetings of the member municipalities.
